JV/consortia) and must clearly reflect who has got the signing powers (signatory of authority) and company profile including the companies' previous 5 years' experience, particularly in the construction/built industry and references must be provided. Bid Evaluation Criteria: The bid evaluation criteria will be the 90/10 Preferential Points System, i.e. 90 points allocated for

price and 10 points allocated for Broad-Based Black Economic Empowerment (B-BBEE) Status Level Contributor. The evaluation will be completed in two stages. Stage one (1): Functionality which is used as a selection criteria and the minimum threshold (points) for qualification is 60% of the 100 points to qualify for stage two (2), based on the 90/10 points

system. . Bidders who scored more than 75 points on DHS/072/13/MP will not be re-evaluated but the department will keep their scored points and their names will be published in the 29 June 2014 print media and on the July 2014 Mpumalanga Provincial Tender/Bid bulletin.
