INTRODUCTION

Our gathering here marks a great achievement in the history of the Mkhondo Local Municipality and its community.

Since 2009, the department embraced a new approach of delivering services in an integrated and sustainable manner.

The broadened mandate and alignment requires the department to create integrated and sustainable human settlements.

It is also about transforming cities and towns into cohesive, sustainable and caring communities with easy access to work and social amenities, including sports and recreation facilities.

The Department will now no longer just implement houses, but play a larger role to coordinate, facilitate and support the provision of all the elements and aspects that constitute a sustainable human settlement.

To measure performance, government has set out clear targets and priorities to be delivered.

The department's priorities are informed by **Outcome 8** that includes among others – improvement of access to basic services, improved property market, more efficient land utilisation, and accelerated delivery of housing opportunities.

The projects handed over today will surely improve and benefit the lives of this municipality in a sense that they talk to our vision of integrating society and fostering social cohesion.

In manifesto, the African National Congress (ANC) makes it clear that there will be a great focus on human settlements as another priority for government.

The focus on this important portfolio is to rid the country of informal settlements and squalor.

Given this marching order by the ruling party, what is then required of this department is to improve its planning and deliver on this requirement.

Our gathering here today is about service delivery – which this government and the ruling party are all about.

Our first project which falls under the Informal Settlements Upgrading Programme was approved in the 2013/14 financial year to deliver 62 low income houses with the total budget allocation of **R5 million**.

The project had economic spin-offs for the locals through job creation and subcontracting.

The delivery of these projects is part of the province's rural development drive – Comprehensive Rural Development Programme (CRDP) – to benefit this municipality as identified as one of the poverty stricken areas in the province.

A total of 100 job opportunities were created during the roll out of the project benefiting mainly locals (8 female adults, 11 male adults 48 male youth)

Another project that we launched is the Enhanced People's Housing Process Programme.

The project was approved in the 2013/14 financial year to deliver **256** low income houses with a budget allocation of **R20 million**.

The approval of the project was an endeavour to restore the dignity of the 256 families that were living in informal settlements without basic services.

The project will assist in improving the living standard, job creation and the economic benefit.

The allocated units are being delivered in various areas, namely eZiphunzini 100, Rustplaas, 50, eMagadeni 56 and Driefontein.

During delivery, 100 job opportunities and 12 for local FET College students as part of skills transfer were created. Two local women are responsible for concrete block manufacturing.

In keeping with the green environment, we have planted trees and gave some to the households to ensure that our environment is clean and sustainable.

I would like to thank all the contributions made by sponsors, government departments, agencies and business people. This is indeed a noble course toward the development of our society.

NEW PLANS

In the current financial year new projects have been planned to benefit this very same community.

The delivery will include **318** low income houses, **186** title deeds and launch of new projects worth **R51 million** that include **375** housing units, a community hall and a child care centre.
