NDP (Vision 2030)

Manifesto (January 8th Statement)

The Freedom Charter states that: "There shall be Houses, Security and Comfort" for all citizens of the country.

This statement compels no one, but this department, of course with other sector departments to ensure that such is realised.

In his January 8th Statement Address, party President Mr Jacob Zuma called for all to go back to basics. "Every single cadre of our movement must know that his or her responsibility is to make local government function better by getting the basics right – wherever they have been deployed".

The party's main concern is that local government continued to be at the coal face of service delivery, however, the governance of many of municipalities is` a cause for grave concern.

So, my appeal to the HOD and managers is to rally behind municipalities and support them in our quest for better service to communities.

Local Government Elections

As we build up to the local government polls, the task ahead of us remains huge.

The need for houses continues and will still continue to envelope municipalities and unsettle communities from time to time.

Much as government has clear policies on delivery of services, the practicality still remains to ensure that they are implemented to the latter.

Uncoordinated planning and other delivery challenges have to be trashed out so as to create an enabling environment to roll out projects.

Our delivery has to influence the outcomes of the up-coming local government elections, thus taking an improved methodology, as opposed to normal operations.

We can take lessons from the community driven project such as Vulindlela Model being rolled-out in Kwa-Zulu Natal.

Department Programmes

Since 2009 the mandate of the Department was broadened.

The widening of the scope required the delivery of services in an integrated and sustainable manner.

The outcome-based approach emphasizes improved coordination of activities amongst all stakeholders.

Simply put, integrated human settlement means that people must have access to all services and social amenities within their jurisdiction.

Economic activities have to be initiated by involving the private sector and explore new innovations.

The Department has to deliver on the following key issues:

- Facilitate the establishment of sustainable integrated human settlements,
- Provide households with basic services,
- Support municipalities with bulk and sewer infrastructure,
- Provisioning of Social and Economic Facilities,
- Informal Settlements Upgrading, and
- Issuing of Title Deeds and provision of housing opportunities to Military Veterans.

Challenges

As we continue to deliberate, take note of improvements to be undertaken to ensure smooth delivery.

These will include, amongst others:

- Appointment of competent service providers,
- Improved project planning, implementation and monitoring,
- Delivery of quality services,
- Sound coordination of stakeholders,
- Focus on vulnerable groups,
- Effective support to municipalities, and
- Deliver projects on time (e.g. Emergency Housing).

Once again, let us welcome HOD Masange and CFO Shipalane in their responsibilities as we all map winning solutions to tackle community challenges.

Let us all join hands and ensure that plans crafted here propel the Department to new height.

I therefore make a call that – When the Sun Rises – We must work hard to deliver human settlements.

Let us move Mpumalanga forward.
